AS STIPULATED BY THE AGREEMENT, A ONE-TIME \$5,000,000 PRINCIPAL PAYMENT IS DUE UPON SALE OF ITS ORANGE FACILITY, INTEREST-ONLY PAYMENTS ARE DUE MONTHLY THROUGH DECEMBER 1, 2023 AFTER WHICH PAYMENTS OF \$58,893 ARE MONTHLY THROUGH MAY 1, 2040, WITH A FINAL BALLOON PAYMENT DUE ON JUNE 1, 2040. THE AMOUNT OF THE SCHEDULED INTEREST-ONLY PAYMENTS AND THE FINAL BALLOON PAYMENT AMOUNTS ARE DEPENDENT ON THE AMOUNTS DRAWN BY THE ORGANIZATION.
